## **Drop off/Pickup Policy:**

- Parent or legal guardian agrees to be responsible for drop-off and pickup of the child participating in the youth fitness program and to supervise the child at all times prior to and after his or her session.
- Children are to be dropped off no more than 15 minutes before the scheduled program begins.
- Children are to be picked up no more than 15 minutes after the scheduled program ends. Guardians of children that are not picked up within 15 minutes of the program session will be assessed a late fee of \$25 for every 15 minutes thereafter.
- Harmony By Karate and Reebok Sports Club/NY, Ltd Lincoln Square Commercial Holding Co. LLC are not responsible for children before or after the program session.
- Children are to be dropped off and picked up in designated program areas only.
- Non-member guardians who drop off or pick up children may not use any fitness area of the Club unless they have paid the a guest fee. Violation of this policy shall result in loss of the children's participation in youth programs.
- Unattended children outside of the designated program areas are strictly prohibited.
- Children may not be in possession of a key for a daily locker, therefore, bags and coats can be left at the coat check.

## **Sickness Policy:**

- Please keep sick children at home. Harmony by Karate reserves the right to send a sick child home at the individual instructor's discretion without a make-up. Please review the attached list of symptoms of contagious conditions. It is extremely important that, if your child exhibits any of these symptoms, you do not bring your child to a class, private or group, not only to avoid infecting others but to allow your child to fully recover.
- Please be sure to completely fill out your child's medical fact sheet and emergency treatment release form in case of an emergency.
- Harmony By Karate is food allergy aware and endeavors to maintain a safe environment for its participants, especially its Youth Program Participants. This requires the commitment and cooperation of all participants. Therefore, please do not bring peanuts, nuts or anything containing nut ingredients into the dojo or the surrounding area.
